**SCOTT FREEMAN**

**Kingwood High School, Class of 1997**



Scott Freeman is a proud 1997 graduate of Kingwood High School and attended school in the Humble Independent School District beginning in 1985 when his family moved to Kingwood. Scott attended Deerwood Elementary in its first year of opening and spent 1st through 5th grade there before attending Creekwood Middle School in 6th grade. When Riverwood Middle School was constructed, Scott moved over to RMS to complete 7th and 8th grade.

Scott is the son of Greg and Linda Freeman and the youngest brother of John and Brian Freeman, both of whom were KHS graduates prior to Scott. Scott's mother, Linda Freeman, has been an Humble ISD elementary school teacher for over 44 years and taught full-time at Willow Creek Elementary for nearly two decades. Linda continues to substitute teach around the school district to this day, which is where Scott's work ethic can be attributed.

After graduating with a business degree in finance from The University of Texas at Austin in 2001, Scott began a career in the financial services business with a defined focus in assisting personal injury victims and their loved ones with financial issues both pre-and-post settlement. Scott is recognized as the nation's most accomplished settlement consultant and is the founder and Chairman of Sage Settlement Consulting, the largest settlement planning firm in the country.

Scott and his employees at Sage work with thousands of law firms across the country on both mass tort and catastrophic single-event injury cases for claimants involved in personal injury, workers' compensation, and wrongful death settlements. In addition to Sage Settlement Consulting, Freeman was the founder of ARCHER Systems LLC in 2013, which became the largest medical lien resolution and claims administration firm in the country. In 2022, ARCHER was sold to the large NY-based private equity firm, Fortress Investment Group, but Freeman remains the Chairman of ARCHER to this day. Scott is also a board member and founding partner of Inspire Trust Company, an OCC-regulated, nationally chartered trust company based in Nevada.

Scott's passion has always been to give back to his community and this is proven in his many philanthropic efforts across the state. He has taken his great personal business success and given back to his community where he proudly supports the KHS Basketball team, the Young Life North Houston chapter, and many more projects local to those in the community in which he grew up. Outside of the Kingwood area, Scott is also a substantial contributor to his alma mater, The University of Texas, the River Oaks Baptist School, Cornerstone Ranch, and the Monarch School.

In 2021, Scott took on his largest passion project and founded the Houston Wildcatters, which is a 501(c)(3) not-for-profit youth baseball organization with over 60 teams competing across the Greater Houston area. With teams ranging from 8U to 17U competing on a national level, the Wildcatters strive to provide opportunities for children from all socioeconomic backgrounds the opportunity to play baseball. For the first 3.5 years of existence, the Wildcatters families paid zero dues as the coaching, practice fields, uniforms, and tournament costs were fully sponsored and underwritten solely by Mr. Freeman. To this day, over 20 teams are able to pay zero fees/dues to the organization and receive the gift of free baseball in a highly competitive environment.

Scott currently resides in Houston, Texas with his wife, Jacklyn, and their four boys (Dylan, James, Noah and Luke). Scott enjoys coaching baseball at Post Oak Little League and attending sporting events across the country.
